

# INDEMNITY

## Peterhouse Equestrian Centre (P.E.C.)

The attached Indemnity form for Peterhouse applies to the Peterhouse Equestrian Centre in all respects and shall form part of this Indemnity Form as if the same were herein set out in full. Riding is considered a sport here at Peterhouse and the children will be covered respectively.

In addition I .....

as parent / guardian of ..... understand that I am leaving my child's horse at the P.E.C (or leasing out a P.E.C horse) (or having lessons for my child on a P.E.C horse) at my own risk. I will not hold the P.E.C or any of its staff or instructors responsible in any way for any damage or loss to my horse or my child's tack. I understand that the P.E.C is situated just out of the school security fence and I am aware that my child has to cross a municipal road to get to the centre.

I am also aware that my child will be riding out of the P.E.C area on outrides and agree that any accident that may occur on an out ride is outside the P.E.C's and the school's control. I give full consent to the P.E.C staff to look after my child while he / she is at the P.E.C. and for my child to participate in all the P.E.C activities. I will not hold the Centre or its staff responsible or liable for any loss or injury to my child whilst at the P.E.C or engaged in any of its activities.

Polocrosse is run out at the Stockil's farm in Marondera North. The children are collected by the instructor and taken out to practice. I give my consent / do not give my consent (delete whichever is appropriate) to play Polo Crosse and for my child to be transported by the instructor to and from practice.

If consent is granted I understand that this sport takes place away from the school campus and that my child will be under the sole supervision of the instructor. Further to that I will not hold the PEC, or the instructor, responsible or liable for any loss or injury to my child whilst being transported to and from, or playing polocrosse.

I fully understand and accept that all rides and outrides shall be undertaken at my child's own risk and I undertake, on behalf of myself, my executors and my child aforesaid to indemnify, hold harmless and absolve the P. E. C. and the principal and staff of the P. E. C. against and from any or all claims whatsoever that may arise in connection with any loss of or damage to the property or injury to the person of my child aforesaid in the course of any such rides or outrides or activities connected therewith.
